We will maintain a record of your information at the offices of Wilson Sports Insurance Services LLC so we can provide you with policyholder service. The employees of Wilson Sports Insurance Services LLC are each required to sign and acknowledge a Confidentiality And Nondisclosure Agreement. Each employee has been instructed on maintaining the privacy of each customer and the importance of protecting the customer's personal information.

When you purchase an insurance policy from Wilson Sports Insurance Services LLC, you will pay the premiums with your credit card or personal check. If you use your credit card to pay the premium, you will be requested to complete a credit card authorization form that must be faxed back to our office. If you pay the premium using your personal check, we will keep a copy of your check in your file. When you send us an e-mail from this Web site, you will provide us with certain personally identifiable information including your e-mail address.
